- At the start of the new financial year 2018-19, the accounts department of companies would have begun asking for the investment declaration from their salary employees. In the absence of such a declaration, the employer will have to start deducting tax at source (TDS) on the employee's full estimated salary income without allowing for tax saving deductions. 7. On receiving such a declaration from an employee, the employer will take into account the propose tax saving deductions from salary income before computing the estimated tax to be deducted at source. This would reduce the total estimated salary income for the employee for the full year and therefore the estimated TDS for the year would also correspondingly get reduced. 8. Commonly used tax saving investments fall on the section 80C of the Income Tax Act which has an annual limit of Rs 1.5 lakh. The declaration, however, will also cover other deductions such as section 80D and section 24 available under the Act that would help the tax payers to reduce their tax liability. 9.
